TERMS AND CONDITIONS

AIR FARE: Air will be quoted separately at the time of booking.

HOTELS: First-class and deluxe hotels as specified. Twin-bedded rooms with bath. There is an additional charge of \$1395 for single occupancy. Non smoking rooms are always requested, but cannot be guaranteed. Advise your tour escort or guide immediately should you have any problems with your room.

MEALS: Breakfast is included daily as shown (B). Lunch (L) and Dinner as shown (D).

SIGHTSEEING & TRANSFERS: By chartered coach or micro-bus or taxi with handling of baggage not exceeding one normal-sized suitcase.

BAGGAGE: Airline baggage requirements will be advised separately. On tour you are allowed one normal-sized suitcase not weighing more than 50 pounds. In addition, carry-on/hand-carry baggage should be limited to one piece, plus an average-sized handbag for women. Sometimes we will ask that you pack an overnight bag while we have the larger bags sent ahead to your next destination. An additional \$25 will be charged for each additional bag forwarded.

GUIDE: An English-speaking local guide-escort will be with us during the course of the entire tour.

GRATUITIES: Are included to porters, drivers, and local guides to the extent of the services included in the tour.

TAXES: On hotel accommodations, included meals, other services, airport taxes and/or passenger facilities at airports are included in the tour. Charges for planning and operation are included. All rates are based upon tariff and exchange rates in effect as of July 2015 and are subject to change without notice.

CANCELLATION: Guaranteed departure requires a minimum of 10 passengers, however we may confirm the tour with less. If the tour is cancelled because the minimum is not reached, you will receive a refund of payment in full for land cost only. Air cancellation is separate, based entirely upon the policies of the respective airline providers. After confirmation, the following cancellation penalties will apply: * deposit is non refundable; * 90-45 days prior to departure, 25% of the tour cost per person will be collected; * 44-15 days prior, 50% of the tour cost per person will be collected; * less than 15 days prior, no refund will be made. Travel protection is highly recommended. Please call our office for a travel insurance brochure.

TOUR FARE DOES NOT INCLUDE: Travel insurance, portage, transportation of heavy baggage and baggage in excess of the above limit; conveyances used for individual purposes; room service charges; airport taxes and or/passenger facilities fees at airports; wine, mineral water, tea and coffee outside table d'hote menu; laundry; service obtaining passports, visas or other documents required for entry; other items of a purely personal nature.
